**ACTION:**

The Bowling Green-Warren County Metropolitan Planning Organization (MPO) hereby modifies the FY 2016 - 2020 Transportation Improvement Program (TIP) to add two recently awarded Transportation Alternatives Program (TAP) projects in Warren County.

PROJECT ID: 2018-22

ITEM #: Not Yet Assigned

DESCRIPTION: Design and construct a 10' shared-use path, with specific intersection improvements, in the West End of Bowling Green. This project will close the gap in existing bike/ped facilities and provide a connection between Downtown and the West End, a minority population area with residents who do not own a vehicle.

PHASE: D, R, C

TYPE OF FUND: TAP

FY: 2017, 2018

AMOUNT: \$550,000

PROJECT ID: 2018-23

ITEM #: Not Yet Assigned

DESCRIPTION: Design and construct a 5' sidewalk on the south side KY 240 from its intersection with Fletcher Street to its intersection with Main Street in Woodburn, Kentucky, including curb, gutter, and drainage work. This project will connect to the existing greenway facility at the Fletcher Street intersection.

PHASE: D, R, C

TYPE OF FUND: TAP

FY: 2017, 2018

AMOUNT: \$148,000

Other Information: This TIP Modification modifies specific funding levels listed for TAP projects in Table 1 of the TIP and adds the listed projects to Table 4. TAP projects are a project type identified in the Grouped Projects Table of the TIP; therefore a TIP Amendment is not necessary. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP and Metropolitan Transportation Plan (MTP) by Administrative Modification. TIP actions for these projects will not require additional public review. The identification of specific projects from the Grouped Projects Table involves a commitment of additional funding for the project by the project sponsor (Kentucky Transportation Cabinet, City of Bowling Green, and City of Woodburn). The additional funding maintains financial constraint of the TIP and MTP documents, and no additional financial constraint analysis by the MPO is needed.
