Federal transportation planning regulations require that all Metropolitan Planning Organizations (MPO) prepare an annual listing of projects for which Federal funds have been obligated in the preceding year. The Annual List of Obligated Projects shall be published or otherwise made available by the cooperative effort of the State, transit operator, and MPO. The listing shall be consistent with the funding categories identified in each metropolitan Transportation Improvement Program (TIP).

The tables that follow provide information on transportation projects that were obligated for spending using federal funds in fiscal year 2023 for the Bowling Green-Warren County MPO area. The obligated amount represents the Federal government's financial commitment to fund the federal share of a project's cost. An obligated project has been authorized by a federal agency. Obligated funding does not infer a project's complete cost or completion, but rather that the specific project has committed federal funds. For informational purposes, obligated state funded transportation projects are also included in this report.

The information provided in this document is consistent with how projects are listed in the Bowling Green-Warren County TIP – projects are shown with a project item number, route identification, project description, project phase, and funding amounts. Federal funding sources are also included for each obligated project listed in this document.
