Warren County Judge-Executive Doug Gorman called the MPO Policy Committee to order.

- 1. Roll Call A roll call was conducted in order to determine a quorum; quorum was determined with all members present.
- 2. Approval of Summary Minutes There was no discussion regarding the December 16, 2024 meeting minutes. Mayor Alcott made a motion, seconded by Joseph Plunk, to approve the December 16, 2024 minutes. All in favor, so approved.

3. New Business

- a) Approve: Transit Management Agreement between City of Bowling Green and MPO for inclusion in the FY2026 UPWP. This document updates and will replace the agreement signed in 2017. A motion was made by Joseph Plunk to approve the updated Transit Management Agreement; Mayor Alcott made a second. All in favor, so approved.
- b) Approve: FY2026 Unified Planning Work Plan (UPWP) document. A motion was made by Joseph Plunk to approve the FY2026 UPWP; Mayor Alcott made a second. All in favor, so approved.
- c) Approve: 2025 Safety Performance Measure Targets. A motion was made by Joseph Plunk to approve the 2025 Safety Performance Measure Targets; Mayor Alcott made a second. All in favor, so approved.
- d) Approve: Strategic Highway Investment Formula for Tomorrow (SHIFT) sponsored projects. A motion was made by Mayor Alcott to approve the SHIFT projects sponsored by the MPO; Joseph Plunk made a second. All in favor, so approved.

- b) City of Bowling Green and WKU transit merger study continues. Last meeting was conducted on 03/13/25 with consultant RLS.
- c) The League of American Bicyclists Bicycle friendly applications:
 - i) Business application has been completed for the MPO and submitted
 - ii) Community (Bowling Green) Progress continues on application (due 6-25-25).
- d) Adopt-A-Trail greenway sponsors update; Approximately 20 trials have been adopted.
- e) Traffic garden at fringe update. Ribbon cutting ceremony is scheduled. 5/6/25, 11:00am.
- f) Warren County Bicycle Copop grand opening is scheduled for 5-3-25, 9:00am 1:00pm.
- g) Awarded \$10,000 through the 2024 Paula Nye Memorial grant submission. Proceeds funds School Bike Education Program and other BikeWalkBG activities. Waiting on funds.
- h) Kentucky Bicycle and Bikeway Commission (KBBC) confirmed that their annual meeting will be held in Bowling Green this Fall. Dates are Friday, 11/7 and Saturday, 11/8.
- i) BikeWalkBG participating in a Study Advisory Committee for a Kentucky Transportation Ctr. research project to study collecting bike/ped data counts. No recent updates.
- j) Conducted School Bike Education Program at four (4) area schools last fall and have four (4) scheduled for this spring. Reaching approx. 1,000 students. Looking for volunteers.
- k) Participating in Duncan Hines days planning. Three (3) BikeWalkBG events planned.
- l) AARP Community Challenge Grant MPO in conjunction with the City of Bowling Green and GoBG Transit has applied for approx. \$20K in funding to place seats at select bus stop locations. Status: Awaiting on award announcement.
- m) May is National Bike Month (established in 1956) National Ride a Bike Day (Sunday, 05/04/25); Bike to Work Week (05/12/25-05/18/25); Bike to Work Day (Friday, 05/16/25)

5. Old Business

- a) Carroll Duckworth attended statewide MPO meeting in Elizabethtown and made BPAC presentation. Bowling Green and Lexington are the only two (2) BPACs in Kentucky.
- b) Quarterly MPO report and invoices were submitted for reimbursement.
- c) The MPO quarterly newsletter was published on 4-11-25.
- d) Carroll Duckworth attended National Bike Summit in Washington, DC in March hosted by The League of American Bicyclists. Participated in leading a panel discussion. Concerned was expressed over the uncertainty of funding.
- e) Received Spark Grant (available in cities with GM plants) \$2,000 award to fund helmets and bicycles for School Bike Education Program.
- f) American Walks Community Change Grant for \$2000-2,200 to fund trash cans along greenways was denied.
- g) Worked with City and GoBG transit to produce a PSA video on how to mount bicycle on a transit bike rack.
